## Answers to these questions:

- Does the proposed rule reference Idaho's MOU on grizzlies (Dan said maybe as a way to note the State's intentions on management). **The proposed Rule does reference the joint state MOA.**
- If the MOU changes, will the rule need to be changed (Dan said he doubted it, because the MOU is voluntary). **If the MOA changes significantly so that in the view of the Service it will increase the threat to the population, the Service may initiate a status review and possibly emergency relist the GYE grizzly bears.**
- Questions were asked regarding baseline numbers for recovery and fluctuations of the baseline and how they relate to states' discretionary mortality limits. (Dan said that we may have some tables with information that we could send.) **Tables 2 and 3 in the Proposed Rule detail the population objective of 674 bears and the mortality management system that will be in place to assure this population objective is maintained. State statutes and regulations that will comply with and implement the details in these tables are necessary for a final rule delisting the GYE grizzly population to be implemented.**
