Jenn,

We are in Bluff for cleanup and more ice.

Regarding the briefing statement on the CS, I think this is a great opportunity to state what the CS is supposed to be and do. Here is an outline of the talking points to give to Matt:

- it is the post-delisting management plan.
- completion of the CS is a recovery plan task.
- the CS needs to be very detailed in all aspects of population and habitat management so that years from now new state and federal managers can use it to manage habitat and mortality and all issues that will allow the population to remain recovered.
- it will be in place in perpetuity. It will always be in place.
- it can be updated as necessary as long as any updates are based on the best available science and are subject to public comment.
- it should reflect the same level of detail as the proposed rule just as these documents (the rule and the CS) we exactly the same in the last delisting in 2007.

Use these as the briefing points.
