Director Ashe, et al. – On March 17, 2016 I submitted the attached letter via the Federal eRulemaking Portal for Docket No. FWS-R6-ES-2016-0042, the U.S. Fish and Wildlife Service's proposed rule concerning Yellowstone grizzly delisting. This letter, which was submitted on behalf of a broad conservation coalition, requests an extension of the public comment period and additional public hearings concerning this proposal. The letter was assigned comment tracking number 1k0-8ojz-q2n5.
