Hi Frank,

The proposed revisions below are very problematic for the states. Over the past year plus of negotiation, this was a major issue that we all collectively agreed we would remain silent on since it is unknown what a future estimator might look like. It is also something the YES Conservation Strategy steering committee already discussed and agreed they would not move forward. It is troubling that the IGBST is now unilaterally moving forward with an approach and a decision that is not consistent with the desires of the agencies (except one), and really is a foray into policy - away from science.

To ensure there is no perception that Montana is supportive of this, or of the IGBST involvement with this, I am directing Montana's members of the study team to not participate any further in this exercise. Additionally, I would appreciate clarification on process the IGBST uses to accept tasks like this that one member agency directs which is against the will of other member agencies.
