## U.S. Fish and Wildlife Service to Host Public Meetings on Proposed Yellowstone Grizzly Bear Population Delisting

**LAKEWOOD, Colo.** – The U.S. Fish and Wildlife Service (Service) will host two informational meetings and public hearings on the Yellowstone grizzly bear population proposed delisting rule on April 11-12, 2016, in Cody, Wyo. and Bozeman, Mont.

The Service is seeking ~~comments~~ scientific data and commercial information on the proposed delisting rule, a draft supplement to the 1993 Grizzly Bear Recovery Plan for the Yellowstone grizzly bear population, and a draft conservation strategy. These documents will ensure robust monitoring of Yellowstone grizzly bears, balanced management and effective conservation going forward. The Service will consider all comments, with an emphasis on all unique issues raised, prior to making any final decisions. Final documents and associated decisions will be based on the best scientific and commercial information available. Please note that submissions merely supporting or opposing a potential delisting, without supporting documentation, will not be considered in making a determination. Petition signatures are not considered substantive comments.

**Comment [SLW1]:** Because this is a rulemaking, APA standards apply which give opportunities for comments. We are not limited to scientific data or information. While I don't like to encourage the idea of a vote, I am not sure how much we should discourage it. In the end, people can vote if they want.

Informational open house meetings will be held from 2-4 p.m., followed by public hearings from 5-8 p.m. both days. Representatives of the Service will be available to answer questions with educational poster sessions during the open houses. Brief presentations will be made by the Service at 2 p.m. and 3 p.m. during the informational meetings, followed by educational poster sessions when you can visit one-on-one with subject matter experts. A presentation will also be made at 5 p.m. The public hearing will start at 5 PM, during the public hearing, followed by with -three-minute testimonies, comments by interested members of the public from the audience. Note, only the public meeting portion allows for question and answer with the public. The public hearing portion is strictly intended as a forum to accept public comments. You are invited to attend either or both sessions:

The ~~restoration-recovery~~ of the grizzly bear in Montana, Wyoming and Idaho during the last three decades stands as one of America's great conservation successes—a testament to the value of the Endangered Species Act (ESA) and the strong partnerships it drives. The Yellowstone grizzly bear population has rebounded from as few as 136 bears in 1975 to an estimated 700 or more today.

Population and habitat monitoring efforts undertaken by the Interagency Grizzly Bear Study Team indicate that grizzly bears have more than doubled their range since the mid-1970s. They now occupy more than 22,500 square miles of the Yellowstone ecosystem, an area larger than the states of New Hampshire, Massachusetts and Rhode Island combined. Stable population numbers for grizzlies for more than a decade also indicate that the Yellowstone ecosystem is at or near its carrying capacity for grizzly bears.
