My name is Alex Kasdin and I am a graduate student fellow working with Seth on various listing and recovery projects over the next eight months. I have been assisting with a number of grizzly bear tasks and will continue to play a role as we bring the final rule across the finish line.

Last week, eight fantastic volunteers helped process the over 160,000 public comments we received on the proposed delisting. We are making great progress!
