So, I've asked Jennifer to come up with a document (1) providing a generalized summary (e.g., peer review largely supportive...), (2) listing the peer reviewers selected by the contractor and describing how they represented a variety of applicable expertise including (i.e., why they were chosen); (3) they generally weighed in on the following issues (list the different areas); (4) the most substantive comments which we are considering at this time included (hopefully a shorter list).
