Dear Mr. Aland:

This letter is in regard to your Freedom of Information Act (FOIA) request dated May 8, 2017 for *“all records, of every kind and character, irrespective of form or format (including paper and electronic records), that were received by the U. S. Fish & Wildlife Service (“FWS”) from, and/or sent by the FWS to, (a) any current or former federal, state or local official or agency, (b) any current or former member of the U.S. Senate or U.S. House of Representatives, (c) any current or former member of the U.S. Executive Branch or (d) any current or former member of the legislature of the State of Idaho, Montana or Wyoming that request, support or oppose, directly or indirectly, removal of grizzly bears in the Greater Yellowstone Ecosystem from the list of protected species under the Endangered Species Act, 16 U.S.C. § 1531 et seq. (“Requested Records”).*” The date range for this request is March 23, 2016 through May 10, 2017 (the date our search began).

We are enclosing one (1) DVD containing six-hundred sixty-three (663) documents (131,406 pages) and four (4) Excel files (6,207 KB) responsive to your request, which are being released to you in their entirety. We are still reviewing documents responsive to your request. Once that review is complete, we will send you our final response.

You may appeal this partial response to the Department’s FOIA/Privacy Act Appeals Officer. If you choose to appeal, the FOIA/Privacy Act Appeals Officer must receive your FOIA appeal **no later than 90 workdays** from the date of this letter. Appeals arriving or delivered after 5 p.m. Eastern Time, Monday through Friday, will be deemed received on the next workday.

**Your appeal must be made in writing.** You may submit your appeal and accompanying materials to the FOIA/Privacy Act Appeals Officer by mail, courier service, fax, or email. All communications concerning your appeal should be clearly marked with the words: "FREEDOM OF INFORMATION APPEAL." You must include an explanation of why you believe the

Service's response is in error. You must also include with your appeal copies of all correspondence between you and the Service concerning your FOIA request, including your original FOIA request and the Service's response. Failure to include with your appeal all correspondence between you and the Service will result in the Department's rejection of your appeal, unless the FOIA/Privacy Act Appeals Officer determines (in the FOIA/Privacy Act Appeals Officer's sole discretion) that good cause exists to accept the defective appeal.

Please include your name and daytime telephone number (or the name and telephone number of an appropriate contact), email address and fax number (if available) in case the FOIA/Privacy Act Appeals Officer needs additional information or clarification of your appeal.
