Hi Betty –

Here is a quick tally, but as usual, it's never as clear as one would hope.

According to the author of that section of the *Management Plan for the Conservation of Wolverines in Idaho*, page 27, the 2 mortalities were from 2 different studies: Copeland's work in central Idaho in the 1990s (1 mortality) and Inman's work in the Greater Yellowstone Ecosystem in the 2000s (1 mortality). In addition to these 2 studies, there also was Heinemeyer's winter recreation study (0 mortalities).

From what I can discern from reports, the breakdown of wolverine captures (not individual wolverines, but rather capture events) per study is as follows:

Copeland: 43 wolverine captures (1 mortality)

Heinemeyer et al: 134 captures (0 mortalities)

Inman: 96 captures (1 mortality)

Copeland and Heinemeyer's studies were essentially within Idaho. This represents 177 captures and 1 mortality.

Inman's study, on the other hand, had very few traps within Idaho and mostly in MT and WY. You would have to contact him directly if you wanted to parse out the number of wolverine captures in Idaho only.

In case my math is wrong or I missed something in these reports, please take these as approximate numbers.
