Good morning Ed,

The July 2016 version does contain Wolverine records, there should be 802 observations. The “*_SSonly” feature class is just a subset of records from the entire ‘Animal_Observations_ *year*’ in an attempt to groups of species that might be of interest to some folks into a smaller dataset. In case you aren’t aware, our agency went through a concerted effort to gather new, and vet existing Wolverine observations within our database in November 2016. These updates will not be reflected within the July 2016 export. I believe this species review either has been or will be submitted to USFWS.

I hope that answers your questions. Please let me know if I can clarify anything additional.

Hello Angie, I work in the GIS section at the USFWS office in Carlsbad, California, and have been in the process of trying to gather all Wolverine observation data across the typical range for our assistance of FWS Region 6.

Kathleen Fulmer in the FWS, Northern Idaho Field Office has been very helpful and suggested that I talk with you about these data.

I requested and was granted approval to use my ScienceBase account to access the IFWIS data and did so earlier this month.

I actually downloaded the July2015 geodatabase, but Kathleen had access to the July2016 and was helpful in providing that.

She also helped with the link below in her email to me, and that lists many of the Wolverine records with the Verification Status.

My problem is, in the July2015 data, both the feature class "Animal_Observations_July15" and "Animal_Observations_July15_SSonly" contain 801 records for wolverine (same records as far as I can tell). However the new GDB's for July 2016 do not actually contain any of those records.

Am I missing something, or were these records pulled for some reason? Or do I need to work with you to have access to the CSV file that we can create from the link Kathleen provided? If so I can build data provided they have coordinates and you can provide the projection information.

I would appreciate any input you could provide with this. The July 2015 has records, but I'd like to use the most up-to-date information if possible.
