Hi All, I just spoke to Kim on the phone. She said the 3 records they have in Utah are 1. camera trap (2014-Uintas). 2. roadkill (2016-Bear Lake) and 3. tracks (2015). They sent the roadkill sample to Schwartz and have the results. The animal didn't match any of the 500 in Schwartz database. Was most closely related to central Idaho.

She said they do have camera traps out now, but haven't picked up anything. No hair snags w camera traps Steve.
