Hi Scott,

I talked with Mike Schwartz from Rocky Mountain Research Station about this again last week. He ran a larger sample of this animal's genome than Chris Kyle did, and he is convinced this is a southwest coastal Alaskan animal. He also said that there was rumored captive released in the area shortly prior to this animal being seen. He thought it was telling that when Kyle's group published their eastern wolverine genetics work (attached) that they didn't mention this animal. I think at this point, parsimony dictates that we conclude this animal to be an escaped captive. Any outreach you would like to do with the State would be appreciated. Let me know if you would like my involvement.

Michigan Thumb Wolverine exhibit to visit state Capitol March 12-15

Michigan Department of Natural Resources Director Keith Creagh will join Sens. Mike Green and Phil Pavlov at the state Capitol in Lansing on Tuesday, March 12, to unveil the Michigan Thumb Wolverine exhibit, featuring Michigan's "lone" wolverine. This was the first wolverine ever authenticated in Michigan, and has been preserved by taxidermy. The wolverine, as well as interpretive panels created by the Michigan Historical Museum, will be on display at the state Capitol through March 15.

The wolverine was discovered in 2004 in Michigan's Thumb area, where it roamed the Minden City State Game Area until its natural death in 2010.
