Hello Betty, page 5 has some info in results. This is from a 2007 report from our study that had 8 chapters, 4 of which are published now. This was a general proximity measurement. I can remember going to a den in the Gravelly Mtns, sticking my ski pole in the snow to stand it up there while beginning to record data about the den, and when I stuck the pole into the snow, to my surprise it went 6" or so through the snow and then through a few sticks, and when I looked down a wolverine was looking back up at me through the hole. So there was as little as 6" of snow over parts of a natal den. While standing there, we did not know where all the den actually was below the snow and debris, so we just took a general measurement in the vicinity. Those are what is in the attached. This was occurring before any discussion about "deep" or "persistent" spring snow, so we were not thinking to make lots of exact measurements all around the site. Also wanted to get in, more the locaitons, and get out, in case our presence was disturbing in some way.
