As for fisher, we've been doing scoring on a few of our recent decisions (Canada lynx (Rollie was there and participated in scoring), white-tailed prairie dog). Whether it's a true modified delphi approach, I don't know. Our ARD asked that we do this at the July 6 meeting w/ ARDs. It's pretty simple and just designed to facilitate discussion around the application of the science in the SSA to the policy questions (E, FF, T, DPS, SPR). And help the ARDs form a recommendation to carry forward to the RD(s) at the July 12 meeting. If R1 would rather not score or only do it w/ certain team members, it is all open for discussion. I can explain our process if you'd like to talk over the phone. I'm pretty open this week other than tomorrow.
