Wolverine SSA: structuring the analysis and planning future scenarios

Dr. Conor McGowan, of the USGS Coop Unit at Auburn University and has been participating in the Service's SSA framework implementation team. He also works with Region 2 on developing tools for implementing the SSA framework. Region 6 is piggy-backing onto an interagency agreement of Region 2's with Conor. Through this agreement, tools and methods for applying the SSA framework are being developed. As part of that work, we can obtain technical assistance for specific SSAs. The development of future scenarios within the context of the SSA framework is an area where more guidance and structure is needed.

This call is intended to initiate a discussion on the development of future scenarios in the context of the SSA framework, the nature of the data available and the extremely tight timeframe to get to a listing decision.
