If you want to prioritize your review, I suggest the DPS analysis (rationale for changing from the 2019 rule and splitting into 2 DPS), and the NCSO (Northern California Southern Oregon) analysis section, which is the individual DPS that includes Oregon.

Within NCSO, might want to focus on the population description/condition section, toxicants, wildfire, and small population size, as those were the issues raised in the last court case.
