Thank you for all of your amazing work under this extremely tight deadline to get a draft of the fisher final rule out to R8 RO, R1 RO, RSOL, and HQ for review by last Friday afternoon (2/28/2020). We did it! Since then, we have received a comment letter from the USFS (includes 15 attachments), and today we heard that we are expecting more information/letters to come in as well. Given that we

completed our document on Friday and are busy working on reviews and responding to reviewer's concerns this week, we will table the new information/letters for now. After we have sent the final rule to HQ next week (and, therefore, have time), we will review the documents. Please note that we can and should receive all new information/letters, but we acknowledge that there is not time to incorporate all of the new information given the court-ordered timeline.
