Or are they hoping fisher move onto this additional acreage (which I assume is managed timberland?)

- Protecting fisher dens and their young by limiting disturbance and impacts to denning structures.
- Promoting the development of habitat structures (snags and slash piles) that would support the fisher.

2. what are the 3 additional apps in process? don't need specifics, but are they also private lands agreements, similar to those for the 2 mill ac above? can I say other agreements are being developed?
