Space Exploration Technologies, Corp. (SpaceX) is planning to conduct its testing on May 13, 2020 at the company's site located near Boca Chica Beach, Cameron County, Texas. The window for testing will be from 9 AM to 9 PM. May 14 and May 15 have been approved as a backup dates with the same hours if needed.

SpaceX has revoked its closure on Tues, May 12 and both Boca Chica Beach and Hwy 4 will be open.

As required for these activities, SpaceX will establish a safety zone perimeter in coordination with local law enforcement that will include temporary closures of Highway 4 and Boca Chica Beach. Cameron County has established a hotline for road closure updates at 956-548-9541, and public notices will also be available online at [www.co.cameron.tx.us](http://www.co.cameron.tx.us)
