### PRIVACY ACT STATEMENT

**Authority:** The information requested is authorized by the National Wildlife Refuge System Administration Act (16 U.S.C. 668dd-ee) as amended and the Refuge Recreation Act (16 U.S.C. 460k – 460k-4).

**Purpose:** The collection of contact information is to verify that the individual has an eligible permit to hunt on one of the National Wildlife Refuges that is designated for big game hunting.

**Routine Uses:** The individual's contact information may be used to verify permit status, provide permittees with permit-related information, and monitor waterfowl hunt activities conducted under a permit.
