Refuge Happenings

October 2023: The Silvio O. Conte National Fish and Wildlife Refuge is presently located in twenty-two different locations in the four primary Connecticut River watershed states of Connecticut, Massachusetts, New Hampshire, and Vermont. The Stewart B. McKinney National Wildlife Refuge is located in ten locations on the mainland and near shore islands along the northern shore of the Long Island Sound in Connecticut.

Planting Trees For Better Habitat

The Connecticut River Conservancy and US Fish and Wildlife staff recently planted 238 native trees and shrubs at the Dead Branch Division of the Conte Refuge in Chesterfield MA. The goal of the project is to enhance fish and wildlife habitat and reduce water temperatures in the larger Westfield River watershed. This planting was funded in part by One Tree Planted as well as the Service.

Protecting Pollinators Year Round!

Refuge visitor service staff welcomed over 150 library patrons at the Mason Square Library, in Springfield, MA, as they visited our popular activity table at the annual Fall Festival. Visitors learned about the importance of "sparing" or leaving a five-by-five-foot square piece of land with leaves, for pollinators like queen bees, ladybugs, and other insects to over winter! Participants also learned how to protect their garden soil from winter's harsh climate, by covering gardens with a blanket of leaves. As a take-home activity, adults and children made seed balls containing native plant seeds, that they could plant and grow, with hopes of attracting pollinators to their backyards next Spring.

Forest Stewards Guild Tour

In October, the Forest Stewards Guild toured the Adaptive Silviculture for Climate Change treatment areas at the Nulhegan Basin Division. The treatment areas are a series of experimental silvicultural trials across a network of different forest types. A variety of adaptation treatments have been implemented and are monitored by researchers with the University of Vermont. The treatments are designed to test various approaches intended to increase structural complexity and species diversity within the forest, with the ultimate goal of improving habitat for specific wildlife species. Partners include the University of Vermont, University of New Hampshire, Dartmouth, US Forest Service, and the Northern Institute of Applied Climate Science.
