National Wildlife Refuge and Management Area Hunting and Fishing Regulations 2022–2023







Welcome:

Patoka River National Wildlife Refuge and Management Area was established in 1994 in Pike and Gibson Counties to conserve and manage habitat for waterfowl and other migratory birds, resident wildlife, and endangered and threatened species. Public hunting is permitted on 10,393 acres and public fishing on 10,455 acres of the 10,918 acres managed to date. In addition to controlled public hunting and fishing, the refuge offers a place for the public to enjoy activities such as wildlife viewing and photography, environmental education and interpretation.

General Hunting and Fishing Regulations

Hunting and fishing regulations are designed to provide safe recreational opportunities through wise use of renewable wildlife resources. Hunting and fishing are permitted in accordance with Federal regulations governing public use on National Wildlife Refuges as set forth in Title 50 of the Code of Federal Regulations.

Individuals accessing the refuge are subject to inspections of permits, licenses, hunting equipment, harvest limits, boats, vehicles and their contents by federal and state officers. Indiana state regulations and refuge specific regulations will be enforced. Refuge specific regulations supersede state regulations. Hunting is allowed only on refuge units described in this document. Only the species listed in this document may be harvested.

Hunting and fishing will be in accordance with applicable State of Indiana regulations subject to the conditions stated below. Brochures may be obtained by mail, at the refuge office, or from the refuge website.

Hours

The Refuge is open for hunting and fishing during daylight hours only with the exception of hunting furbearers. The refuge is open for night hunting of furbearers (coyote, raccoon, fox, opossum, skunk).

White River Bottoms Wildlife Management Area.

The 219-acre White River Bottoms WMA is located northwest of Petersburg, Indiana on River Road. This WMA is open to hunting and fishing consistent with the species and regulations described in this brochure.

Columbia Mine Preserve Special Regulations

The Columbia Mine Preserve only open to deer hunting during the first week of the state defined archery, gun, and muzzleloader seasons and for the spring turkey hunting season. It is closed to hunting of all other game species. Additional regulations are in place on the Columbia Mine Preserve, please see the refuge website or contact the office for further information.

Cane Ridge Wildlife Management Area

Cane Ridge WMA is closed to hunting and fishing. The area is open for wildlife viewing at the observation deck and from county roads only.

Firearms

Persons possessing, transporting, or carrying firearms on National Wildlife Refuge System lands must comply with all provisions of State and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32.)

Ammunition

You may only use or possess approved nontoxic shot shells while in the field. Pick up and take out spent casings.

Motorized Vehicles

All motor vehicles must remain on maintained roads and parked so as not to interfere with other traffic. **Off-road vehicles** are not permitted on refuge lands.

Dogs

Dogs are allowed for hunting according to State regulations during designated seasons only. Otherwise, dogs must be leashed. Dog training or running in the off- season is prohibited.

Duck/Goose Blinds and Decoys

Pits or permanent blinds may not be constructed or used on the refuge area. Only portable blinds or structures constructed of native plant materials are permitted for waterfowl hunting. Blinds must be removed or dismantled at the end of each day's hunt. Decoys must be removed at the end of each day's hunt.

Deer/Turkey Stands

Permanent tree stands/blinds may not be constructed or used on the refuge area. Hunting from a tree into which a metal object has been driven is prohibited. Portable tree stands may be used for deer or turkey hunting and may be left overnight only during the periods specified for public lands in Indiana. Tree stands must be legibly marked with owner's name, address and phone number at eye level or lower.

Fishing Regulations

State regulations apply as to license, seasons, sizes, limits, methods of take and species of fish to be taken with the following exceptions:

- We allow fishing only with rod and reel, pole and line, bow and arrow, or crossbow
- Limb lines, jug lines, trot lines, and snares are prohibited as the method of catching fish in refuge waters other than the Patoka River channel.
- Fishing is permitted during daylight hours only.
- Minimum size limit for largemouth bass on Snakey Point Marsh and on the Columbia Mine Preserve is 14 inches.
- Minnows, crayfish, mussels, frogs and turtles are protected and may not be collected or harvested.

Boats

- On refuge property, motorboats are only permitted on Snakey Point Marsh east of the South Fork and on the Patoka River.
- Motorboats on Snakey Point Marsh are restricted to slow speed/minimum wake.
- To minimize disturbance to wildlife, gasoline powered motorboats are not permitted on other refuge waters.
- Air boats are prohibited on all refuge waters.
- Boats may not be left on refuge property overnight.
- Special boating regulations apply for the Miller Bridge Wetland Area and are posted on-site and available at the Refuge Headquarters.

Prohibited Activities


- Littering/dumping including spent shotshell casings.
- Use or possession of alcoholic beverages while hunting.
- Target practice or random shooting.
- Camping/overnight parking.
- Trapping furbearers.
- Open campfires/swimming.
- Taking or attempting to take any wildlife not authorized in these refuge regulations.
- Accessing the refuge across private property without permission.
- Taking, cutting or destroying any plants or parts thereof including flowers, fruits, nuts, fungi, herbs, shrubs or trees other than specified for temporary blind construction.
- Use of off-road vehicles, horses, mules, llamas and bicycles other than on maintained road rights-of- ways.
- Marking trails with tape, ribbons, paper, paint tree blazes, etc.
- Baiting or hunting over bait including salt.
- Blocking gates or roadways with vehicles.
- Searching for or removing any object of antiquity including arrowheads, pottery, beads, etc. Use of metal detectors or digging for artifacts.
- Spotlighting.
- Use of fireworks, trail cameras and drones.
- Unless specifically listed as a permitted use, all uses of natural resources on the refuge are prohibited.

State regulations apply for bag limits. Safety Zones

Discharge of firearms within 150 yards of any dwelling or building on or adjacent to the refuge is prohibited. Hunters are cautioned to identify their targets before shooting. In addition to other hunters, non-hunting visitors are present on the refuge throughout the year and may be on the property at any time.

Hunting is prohibited within 50 yards of the following designated trails: Buck's Marsh Boardwalk Trail, South Fork Trail and Otter Run Trail.





Welcome

Columbia Mine Preserve consists of 1,043 acres. This area was acquired in 2012 by the Sycamore Land Trust. Because the Columbia Mine Preserve is privately owned, this area is subject to different public access and use regulations. Public use is managed through a cooperative agreement with Patoka River National Wildlife Refuge and Management Area. The 48 acres of Refuge owned land North of CR 475 S is managed under the same regulations as the Columbia Mine Preserve.

The Columbia Mine Unit is open from onehalf hour before legal sunrise to one-half hour after legal sunset.

Hunting Regulations

Columbia Mine Preserve is closed to hunting all game animals except for:

- 1. White-tailed deer during the first week (7 days) of the State-defined seasons for:
- Archery
- Firearms
- Muzzleloader
- 2. Wild turkey only during the Statedefined spring season. Fall season wild turkey hunting is prohibited.

Only portable tree stands may be used. These stands can be on the Columbia Mine Preserve during the special season and for a 2-day grace period before and after each special season. Name, address and phone number must be legible and marked on each stand no higher than 6-feet off the ground. Hunting from a tree into which a metal object has been driven is prohibited.

Fishing Regulations

- Wear hunter orange hat or vest during listed hunting season dates.
- All lakes are open to fishing on the Columbia Mine Preserve with access only on foot.
- Several lakes are very deep with steep slippery slopes near the shorelines.
 Always use caution before deciding to wade while fishing.
- Boats 14-feet long or less are permitted.
 No gasoline-powered boats or airboats are permitted.
- Boats must be clean and free of any plant or animal material or water.
- Fishing is permitted from legal sunrise to legal sunset.
- Fishing is only permitted with rod and reel or pole and line.

- Minimum size limit for largemouth bass is 14 inches on Columbia Mine Preserve and Snakey Point Marsh.
- Minnows, crayfish and all reptiles and amphibians are protected and may not be killed, collected or in possession when on the property.

Please take notice:

- All general refuge public use regulations apply when on the Columbia Mine Preserve. Enforcement of use regulations will be carried out by both Federal and State Conservation Officers.

Firearms



Safety Notice!

All visitors in the field on Columbia Mine Preserve must wear fluorescent orange hat or vest in areas open to hunting during hunting season.



Prohibited Activities

- By law, recreational activities on national wildlife refuges are prohibited unless expressly permitted.
- Possession of alcoholic beverages
- Camping, fires, overnight parking and littering/dumping.
- Target practice or random shooting.
- Swimming.
- Use of fireworks.
- Dogs running loose or not on leash.
- Searching for or removal of any natural items such as antlers, animal skulls, plants, historic, and archaeological features, are protected by Federal law.
- Trapping furbearers or other animals.
- Use of off-road vehicles, horses, mules, llamas, and bicycles other than on maintained county road right-ofways.
- Use of electronic or photographic trail monitoring devices and drones
- Marking or flagging any tree or other Refuge feature with reflectors, paint, or other substance.
- Blocking gates or roadways with vehicles.
- Use of airboats and gasoline-powered boat motors.
- Access to the Refuge from private property without permission.
