Eastern Neck National Wildlife Refuge (refuge) is part of the Chesapeake Marshlands National Wildlife Refuge Complex. The refuge is one of over 560 national wildlife refuges in the United States whose primary objective is to provide habitat for the conservation and protection of wildlife. The refuge is situated along the mouth of the Chester River and the Chesapeake Bay, and provides an important migration and wintering habitat for migratory birds, namely waterfowl.

The refuge will host its annual Spring Youth Turkey Hunt April 15, 2023 and April 22, 2023. Review the instructions and complete the enclosed form. The refuge partners with the National Wild Turkey Federation to provide a quality and educational Youth Turkey Hunt.

Application Instructions:

- 1. Only youths ages 12 through 16 on the day of the hunt who were not chosen for previous youth turkey hunts are eligible.
- 2. All interested applicants must complete a Big Game Hunt application form. Applicants must complete all boxes in sections 3, 6, 8a, and 9. In Section 6, please indicate your first and second choice for your hunt date April 15 or April 22, 2023. If you are selected and your first date choice is full, you will be offered your second date choice.
- 3. Both the applicant and the applicant's guardian must sign the application.
- 4. Please fill out the Photo Release Form 3-2260.
- 5. Completed applications for permits must be received by March 23, 2023. Email applications to <u>easternneck@fws.gov</u> no later than 3 pm on March 23, 2023.

Information/Regulations:

- 1. The drawing to select youth hunters will be held on Friday March 24, 2023, and all successful applicants will be notified by telephone on March 24, 2023 by 1 pm.
- 2. Eastern Neck National Wildlife Refuge (refuge) Youth Turkey Hunt permits are non-transferable.
- 3. The refuge Youth Turkey Hunt permit is valid only when signed by refuge staff.
- 4. Youth hunters must email (<u>easternneck@fws.gov</u>) their valid state hunting license one week prior to the hunt day.
- 5. The morning briefing will be held at 5:00 am the day of the hunt at the refuge office/ headquarters.
- 6. Youth hunters must possess a valid hunting license and carry the license with them on the day of the hunt.
- 7. Youths (ages 12 through 16 years of age on their hunt date) must be accompanied by a licensed, non-gun carrying adult from the National Wild Turkey Federation. The National Wild Turkey Federation will provide a guide for all youths selected. Youths may also be accompanied by a non-gun carrying parent or guardian.
- Legal hunting hours are one-half hour before sunrise to noon.
 Sunrise April 15, 2023: 6:28 am
 Sunrise April 22, 2023: 6:17 am
- 9. Loaded weapons are not permitted in parking areas or on paved or graveled roads.
- 10. Hunting of turkey is permitted only in designated areas of the refuge. See 2023 Turkey hunt map on page 4.
- 11. Bag limit is one bearded turkey.
- 12. All other Maryland State rules and regulations related to the state's spring turkey season are applicable and will be enforced during the special hunt on the refuge.

Additional Information/Regulations related to COVID-19

Before considering applying in the hunt please consider whether the youth hunter or parent/guardian meet criteria for high risk for serious complications per CDC guidelines (e.g. age (>65), and/or anyone with underlying conditions i.e. lung issue, heart issue, diabetic) (CDC High Risk Complications). If you are considered high-risk, consider the prevalence of COVID-19 and the likelihood that mitigation measures are more than adequate given the increased risks.

All youth hunters and parents/guardians on the refuge must follow appropriate safety protocols as a result of COVID-19.

A Health Self-Assessment should be taken the morning of your turkey hunt for both the youth hunter and the parent/guardian

• Do you have any COVID-19 indicative symptoms (e.g., dry cough, shortness of breath, fever, chills, headache, muscle pain, sore throat, or loss of taste or smell)?

• Have you had any known exposures (or likely exposures) to individuals positive for COVID-19 in the past 14 days?

If you answered yes to any of the questions above, cancel your hunt.

A mask will be required for all people in the turkey blind at all times.

Exposure to COVID-19 represents a significant health hazard through potential exposure to infected individuals as well as contact with contaminated surfaces. The following measures must be applied: Adhere to all current CDC guidance. At a minimum, you should:

· Maintain a social distance of at least 6 feet between you and other individuals.

• Wash your hands frequently and for a period of no less than 20 seconds or use a hand sanitizer, that contains at least 60% alcohol.

· Cover any cough or sneeze with the inside of your elbow or a tissue that you then discard.

· Refrain from touching your face, mouth, and eyes until you have thoroughly cleaned your hands.

· Use face covering when other individuals are present and avoid touching the face covering except when needed to don or doff it. Face covering is not a substitute for proper social distancing. https://www.cdc.gov/coronavirus/2019ncov/prevent-getting-sick/prevention.html

• Wear gloves or use paper towels when opening gates or any other surface. Gloves can carry the virus, so wearing them is not a fail safe. When wearing gloves, do not touch your face.
