1. Fields designated to be corn food plots will use un-treated and non-GMO seed. It is the responsibility of the cooperator to purchase and plant the correct seed. There will be corn fields designated as delayed harvest. These fields will be designated Sept. 1. They can be harvested after March 1. **In 2024 10.5 ac. of corn will be delayed harvest. 2025 there will be 8.6 acres and in 2026 10.5 acres will be left for delayed harvest.**
2. The cooperator will use end rows on all crop fields. Field boundary markers will be Respected. Field size shall not increase. Care shall be taken when spraying herbicide on crop fields to not over spray on adjacent cover.
3. Hay fields may be cut one time between Aug. 1 and Aug. 15. Bales will be removed immediately.
4. Acreage figures appearing in the lease may not be the basis for federal farm program payments. It shall be the cooperators responsibility to determine the extent of the farm program benefits that are available.
5. Only herbicides from the pre-approved list may be used.
6. Neonicotinoids are prohibited (treated seed).
7. Insecticide use is prohibited.
8. Fall tillage is not allowed.



Instructions:

1. Complete this bid sheet and attach (staple) to the Special Use Permit (SUP) Application with page 1 completed of the SUP Application. If you are the winning bidder you will complete the remaining portions of the Application once the bid is accepted.
2. The bid will be placed with the SUP Application and mailed or turned in to Iowa DNR Great Lakes Wildlife Unit at: 2248 125th St., Spirit Lake, IA 51360 by 4:00 P.M. on Friday Feb. 23rd, 2024. Bids will be awarded on Monday, Feb. 26th, 2024. Winning bidder will be notified by DNR wildlife Unit staff.
3. You will need to evaluate the bid solicitation for each unit and the cropping plan for each of the next three years, and place your total bid. This will be your competing bid, and highest bid will be awarded. In the event of a tie bid, the winning bidder will be randomly drawn from the tying bidders.
