Bids will be awarded on Monday, Feb. 26th 2024. Winning bidder will be notified by DNR wildlife unit staff.
3. You will need to evaluate the bid solicitation for each unit and the cropping plan for each of the next three years, and place your total bid. This will be your competing bid, and highest bid will be awarded. In the event of a tie bid, the winning bidder will be randomly drawn from the tying bidders.







1. Fields designated to be corn food plots will use un-treated and non-GMO seed. It is the responsibility of the cooperator to purchase and plant the correct seed. There will be corn fields designated as delayed harvest. These fields will be designated Sept. 1. They can be harvested after March 1. **In 2024 there will 23.6 acres delayed harvest. In 2025 22.0 acres will be delayed harvest. In 2026 23.6 acres will be delayed harvest.**
2. The cooperator will use end rows on all crop fields. Field boundary markers will be respected. Care will be taken when spraying Roundup on cropland, so as not to kill adjacent cover. Field size shall not increase.
4. Hayfields will be baled one time between Aug. 1 and August 15. Bales will be removed immediately. (Unless specified as part of planned prairie establishment.)

5. Acreage figures appearing in the lease may not be the basis for federal farm program payments. It shall be the operators' responsibility to determine the extent of the farm program benefits that are available.
6. Only herbicides with a Pesticide Use Proposal (PUP) may be used.
7. Insecticide use is prohibited.
8. Neonicotinoids are prohibited. (treated seed)
9. Fall tillage is not allowed.
