

Bond Swamp Refuge is part of a system of more than 560 National Wildlife Refuges, which provide for the conservation and management of habitats to benefit fish and wildlife. The Bond Swamp National Wildlife Refuge was established on October 16, 1989 to protect wetlands and adjacent upland habitats on the Ocmulgee River floodplain. The refuge strives to provide quality hunting and fishing opportunities when compatible with the refuge management objectives.

The refuge is open to the public year round for visitation and pre-hunt scouting during day light hours, **except during firearm deer hunts.** The refuge is primarily river swamp with creeks and sloughs traversing the entire area. When the Ocmulgee River overflows its banks, the floodplain may remain flooded for weeks. Access by vehicle and foot may be difficult. Portions of the refuge may be closed during periods of high water.

#### Brown's Mount

All hunting and fishing are prohibited at Brown's Mount. Brown's Mount is open to the public for visitation year round during daylight hours.



#### General Hunt Regulations

Public hunting is permitted on approximately 7,764 acres of Bond Swamp National Wildlife Refuge with a refuge hunting permit. Areas closed to hunting are marked with signs and orange paint. The refuge boundary is marked with signs and yellow paint.

Refuge hunt permits and quota hunt permits are required for all hunters and anyone who accompanies them.

In addition to Federal regulations, State Game and Fish laws and regulations are adopted and in effect unless they have been further restricted by Federal law or regulations. Licenses, permits, all hunting and fishing equipment and effects, and vehicles or other conveyances are subject to inspection by Federal and State officers.

All game killed counts toward state daily and season limits. Some access roads may be closed due to high water, bad weather, or other management considerations.

**Hunter access is permitted from two hours before legal sunrise to two hours after legal sunset during open seasons.**

**Disposal of carcasses or entrails** – Permitted refuge hunters and fishermen may dispose of carcasses and entrails

of game and fish legally taken from the refuge on the refuge. Carcasses and entrails may be placed in the woods, but may not be placed within 25 yards of any road, trail, gate, boat ramp, parking area, or private property.

#### Hunter Education / Children

Hunters age 16-25 must possess the hunter education certificate while hunting. Children age 15 and under must remain within sight and normal voice contact of an adult age 21 or older possessing a valid hunting or fishing license to hunt or fish on the refuge.

One adult may supervise no more than one youth hunter during refuge quota deer and turkey hunts. Youth hunters, age 15 and under, may hunt on the deer and turkey quota hunts with a permitted adult by obtaining a free refuge youth permit. Youth hunters cannot apply individually for any quota hunt except the quota youth deer hunt. During waterfowl quota hunts, youth hunters count toward party size of three.

#### Big Game Hunting

No hunter sign-in is required. All big game and feral hogs must be checked on the day killed at a refuge check station as designated before leaving the refuge. The whole animal, except entrails, must be brought to the check station. Check stations are located on the east side of the refuge at the Stone Creek Parking Lot and on the west side at the Barnes Ferry Road Parking Lot.

During deer archery and deer firearm quota hunts, deer must be recorded on the hunter's state harvest record at the site of kill. During quota hunts there is a two deer limit per hunter.

During refuge quota turkey hunts, harvest counts toward a hunter's season limit of three gobblers. Refuge limit is one gobbler per hunter.

**All deer and turkeys harvested on the refuge must be checked at the refuge check station on the day of kill AND with the new Georgia DNR Game Check System.**

Hunter orange is required to be worn during all deer firearm hunts and during deer archery hunt when the State deer primitive weapon and gun season are open. At least 500 square inches of hunter orange must be worn as an outer garment above the waist.

Feral hogs may be taken incidental during any refuge hunting season by permitted hunters utilizing legal weapons designated by state law for the specific game species for which the refuge is open. Feral hogs must be checked in whole, except entrails, on the day killed, at a refuge check station.

**WARNING:** Feral hogs can carry infectious diseases that are transmissible to people. To avoid possible exposure, wear plastic gloves when field-dressing feral hogs; wash hands with soap and hot water immediately afterwards; avoid direct contact with blood and reproductive organs; cook thoroughly; and properly dispose of all waste.

Use of dogs for hunting deer or feral hogs is prohibited.

#### Youth Quota Deer Hunt

The youth quota deer hunt is November 12-13, 2016. Youth must be accompanied by a non-hunting adult age 21 or older in possession of a valid hunting and big game license. Only youth between the ages of 10 and 15 on the days of the hunt may participate and apply for the youth quota deer hunt. Adults may not hunt during the youth quota deer hunt. Youth must include their age on dates of hunt on the application. See section on how to obtain permits.

#### Tree Stands / Hunting Blinds

Tree stands and hunting blinds may be placed the day prior to each big game hunt and must be removed by 11 am the day after the hunt.

#### Small Game

During the Refuge small game season only squirrel, rabbit, and quail may be taken. Weapons are limited to firearms and archery equipment listed in the state game laws for small game.

**Only federally approved nontoxic shot (i.e. steel, bismuth, tungsten, etc.) for shotguns is allowed for hunting small game including squirrel, rabbit, and quail.**

Hunting dogs may be used to hunt squirrel, rabbit, and quail. Hunters using dogs may not hunt from their vehicle by driving while dogs are out hunting along roads. Hunters must be out of their vehicle and off roads open to vehicle traffic.

Feral hogs may be taken incidental during any refuge hunting season by permitted hunters utilizing legal weapons designated by state law for the specific game species for which the refuge is open. Feral hogs must be checked in whole, except entrails, on the day killed, at a refuge check station.

Dogs are not allowed for hunting feral hogs.

**Hunter orange is required to be worn during all small game hunts. At least 500 square inches of hunter orange must be worn as an outer garment above the waist.**

#### Waterfowl

Hunting is only permitted by quota hunt drawing. Quota hunt dates are during the state waterfowl season on specified Fridays, Saturdays or Sundays in December and January.

Hunting dogs are allowed for waterfowl hunting.

Hunting is only allowed on designated dates from 30 minutes before sunrise to 12 noon.

Only federally approved nontoxic shot (i.e. steel, bismuth, tungsten, etc.) for shotguns is allowed for hunting waterfowl.

Only waterfowl quota permit holders may bring up to two (2) additional persons who are allowed to hunt, but they all must hunt and remain together as a group.

#### Disabled Hunters

Hunters that are confined to a wheel-chair for mobility, having special needs, should contact the Piedmont Refuge Office for information.

#### Sport Fishing Regulations

Fishing is open March 1 through October 31, from sunrise to sunset.

Fishing is permitted in all areas not designated as closed. Fishing is not permitted at Brown's Mount.

Species and limits: same as State regulations.

Fishermen may use only rod and reel or pole and line to fish. Two poles per person allowed. Fishermen may not possess, place, or throw feeds to attract fish.

Fishermen may not use or possess alcoholic beverages while fishing on the refuge.

**Fish Consumption Advisory** – The State of Georgia EPD recommends only eating one meal per week of largemouth bass and one meal per month of flathead catfish taken from the Ocmulgee River (below Macon in Bibb and Twiggs Counties).

#### Boats

Boat launching is permitted at Stone Creek Boat Launch. Non-motorized boats or boats with electric motors are permitted. During periods of high water, boats may also be launched from refuge roads normally open to vehicle traffic.

After launching boats at the Stone Creek Boat Launch, vehicles and trailers must be parked in the Stone Creek Parking Lot.

Gasoline motors are only allowed during periods of high water. High water is defined by a reading of 18.0 feet or higher at the Macon Gauge on the Ocmulgee River ([http://waterdata.usgs.gov/ga/nwis/uv?site\\_no=02213000](http://waterdata.usgs.gov/ga/nwis/uv?site_no=02213000)).

State boating laws and equipment requirements are in effect.

#### ATVs

Use of ATV's or UTV's is prohibited except by disabled hunters (wheel-chair bound for mobility) with a refuge Special Use Permit. Contact the Piedmont Refuge Office for information.

#### Commercial and Special Use Activities

No person, including but not limited to a guide, guide service, outfitter, club, or other organization shall provide assistance, services, or equipment on the refuge to any other person for compensation. For the purpose of this regulation, any fee paid or services rendered to a person for lodging, meals, club membership or similar services will be considered compensation. Violations of this regulation subjects each hunter, fisherman, or member in the party to a fine if convicted.

A refuge Special Use Permit is required for all commercial activities on the refuge including but not limited to commercial filming and photography; collecting plants or parts of plants; collecting wildlife, mussels, mushrooms, or other resources.

#### How to Get Refuge Permits

**Refuge permits are required for all hunters and fishermen and anyone who accompanies them.** In addition to refuge permits all state license requirements must be met. The Refuge requires all hunters and fishermen to have a paper copy of their state licenses and harvest record in their possession while participating on refuge hunts or fishing. A Georgia WMA license is not required since the refuge is NOT a state area. **Refuge permits are NOT transferable. When signed, this brochure serves as your permit for fishing, small game, and deer archery hunts.** Additional permits may be obtained at the Stone Creek, Longleaf Pine, Barnes Ferry, and Griffin Road parking lots, the Piedmont Refuge Visitor Center, on the web at [www.fws.gov/bondswamp](http://www.fws.gov/bondswamp), or by mail.

Deer, waterfowl, and turkey quota hunt applications must be obtained from the Piedmont Refuge office. A quota hunt permit is required for all hunters and anyone who accompanies them, participating in designated quota hunts. The Refuge will mail requests made by phone, mail, or email, to a postal address. Electronic copies are not available.

Application forms for the deer gun and waterfowl hunts will be available in July and must be returned to the Piedmont Refuge office by **12:00 noon on September 28, 2016.** A public drawing will be held at **1:00 pm September 28, 2016.** Applications for the spring turkey hunts will be available in January and must be returned to the Piedmont Refuge office by **12:00 noon on February 15, 2017.** A public drawing will be held at **1:00 pm February 15, 2017.**

#### General Prohibited Activities

■ Taking, collecting or disturbing any artifact, property, plant, wildlife or part thereof; other than that specifically permitted by refuge regulation

■ Taking or possessing frogs, turtles, snakes, or other amphibians or reptiles

■ Feeding of wildlife

■ Entering refuge during deer firearms hunts without a refuge quota hunt permit

■ Entering refuge hunt areas during refuge turkey hunts without a refuge quota hunt permit

■ Possession or use of alcoholic beverages. Possession of alcoholic beverages by persons under age 21.

■ Persons possessing, transporting, or carrying firearms on National Wildlife Refuges must comply with all provisions of state and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32).

■ Hunting or shooting from or within 50 yards of a road open to vehicle travel or 200 yards of a building

■ Possess or hunt with buckshot

■ Possess or hunt with lead shotgun ammunition, during small game and quota waterfowl hunts

■ Target shooting or non-hunting discharge of firearms

■ Possess or use of any suppressor on any firearm

■ Possess, place, and/or hunt over any feed or attractants (baiting)

■ Use of trail or game cameras or leaving any other electronic device on the refuge

**General Prohibited Activities-continued**


- Man-drives for deer or feral hogs
- Removing live hogs from refuge
- Hunting deer or hogs with or by aid of dogs
- Possess or use of any night vision or thermal imaging equipment
- Possess or use of any electronic calls
- Training dogs or release of birds
- Falconry
- Driving metal objects into trees or hunting from a tree in which metal objects have been driven
- Marking trails with flagging, blazing, painting, paper, trash or other devices
- Off road vehicle travel. Vehicle travel is limited to roads designated as open to vehicles
- Use of ATVs, UTVs or other off road vehicles
- Leaving vehicles, boats, or trailers on refuge overnight
- Overnight camping and/or parking
- Blocking refuge road, boat ramp, or gate with vehicles or vehicle travel around a closed gate
- Bicycles on foot travel roads or off road; Bicycles are restricted to roads designated open to vehicles
- Disturbing, annoying, or interfering with other persons
- Use audio equipment, noise making devices, or generators
- Possess or use of drones or unmanned aerial vehicles (UAVs)
- Open fires
- Unleashed pets
- Littering
- Horses or mules
- Walking on or along railroad track or railroad right-of-way
- Placing or leaving carcasses or entrails within 25 yards of any road, trail, gate, boat ramp, parking area, or private property


