### **Spring Turkey Hunting at DeSoto National Wildlife Refuge**

**Missouri Valley, Iowa** - DeSoto National Wildlife Refuge will be open to public archery turkey hunting from April 14th through May 18th. A refuge Archery Turkey Hunting Access Permit is required and can be obtained free of charge at the DeSoto Visitor Center, which is open daily from 9:00 am to 4:30 pm. It is also available online at [http://www.fws.gov/refuge/Desoto/visit/visitor\\_activities.html](http://www.fws.gov/refuge/Desoto/visit/visitor_activities.html). The permit includes a map showing the areas that archers can hunt. All hunters must be properly licensed, follow all applicable state and federal regulations and carry the refuge access permit while hunting.

The refuge will hold two youth shotgun turkey hunts on April 12-13th and May 17-18th. Interested youth hunters may apply for the hunt by submitting their name address and telephone number. Applications should be sent to DeSoto National Wildlife Refuge, 1434 316th Lane, Missouri Valley, IA 51555. A random drawing for the limited slots will be done on March 3rd. All applications must be received by that time.

A shotgun hunt for mobility impaired hunters will be held on May 17-18th. Interested mobility impaired hunters can find out more about the hunt by calling Mindy Sheets at 712-388-4802.

An entrance permit is required for all vehicles on days other than fee free days. The regular daily entrance fee for private vehicles is \$3.00. Permits may be obtained at the pay stations near the entrances or at the visitor center. The charge for commercial vans and buses is \$20, or \$30 if 21 or more people are aboard. Annual permits, including the \$15 DeSoto Refuge Pass, can be obtained at the visitor center.

DeSoto & Boyer Chute National Wildlife Refuges are located north of Omaha, Nebraska along on U.S. Highway 30 between Missouri Valley, Iowa and along U.S. Highway 75 near Ft. Calhoun, Nebraska.
