SUBJECT: Public Comments Sought on Proposed 3d Seismic Survey Program on Kenai National Wildlife Refuge

The U.S. Fish & Wildlife Service invites public comments on a draft Environmental Assessment (EA) for a proposed winter 3D seismic survey program to be conducted by NordAq Energy, Inc. in the northern portion of the Kenai National Wildlife Refuge (NWR) beginning in January 2013 and completed by April 30, 2013. The draft EA is available for public review and comment until December 15, 2012. The draft EA describes the proposed seismic survey operation and documents the site-specific analysis of the 3D seismic acquisition program. Two alternatives were evaluated in detail - NordAq's proposed 3D seismic survey acquisition program and the No Action alternative.

The 48-square mile seismic survey area would be located west of the Swanson River Oil and Gas Unit and east of the Cook Inlet coastline on surface lands managed by Kenai NWR and on subsurface in-holdings owned by Cook Inlet Region, Inc. (CIRI). CIRI has entered into a lease agreement with NordAq Energy, Inc to develop these gas resources. Regulations require Kenai NWR to grant adequate and feasible access to owners of valid in-holdings for economic and other purposes, subject to reasonable regulation to protect the natural and other values of the Refuge.
