You may apply in person at the Refuge Office in August (Mon. – Fri. 7:30 a.m. to 4:00 p.m.). Or you may mail the application to Laguna Atascosa NWR, 22817 Ocelot Road, Los Fresnos, TX. 78566. Mailed applications must be postmarked during the month of August of the current year to be accepted. Faxed applications will not be accepted.

- Applications received or postmarked before or after August of the current year will be voided.
- Your name may appear on only one Firearm Hunt Application. Applicants listed on more than one application will have all applications voided.

Note: DO NOT submit the hunt fee payment with your firearm application. There will be a computer random drawing in early September. If you are selected for one of the hunts, you will be notified by mail/email and asked to make payment by a date specified in the notification letter.

Laguna Atascosa National Wildlife Refuge reserves the right to deny or revoke any permit due to regulation infractions, aggressive and abusive demeanor or any reason that displays an act of unprofessionalism to any Refuge personnel or fellow hunters.

Privacy Act Statement - Firearm Hunt Permit

NOTICE: In accordance with the Privacy Act of 1974, 5 U.S.C. 552a, as amended, please be advised that:

2. Information collected in this application may be used to evaluate and conclude the eligibility of, or merely document, permit applicants.
3. Routine use disclosures may also be made (1) to the U.S. Department of Justice when related to litigation or anticipated litigation; (2) of information indicating a violation or potential violation of a statute, regulation, rule, order or license, to appropriate Federal, State, local or foreign agencies responsible for investigating or prosecuting the violation or for enforcing or implementing the statute, rule, regulation, order or license; and (3) from the record of the individual in response to an inquiry from a Congressional office made at the request of that individual.
4. Any information requested is required to receive a permit. Failure to answer questions may jeopardize the eligibility of individuals to receive a permit.
