Thank you for your interest in the Mason Neck and Occoquan Bay Management Hunts, coordinated by the Potomac River National Wildlife Refuge Complex, Mason Neck State Park in Fairfax County, and Virginia Department of Game and Inland Fisheries. Please read the hunt application form closely to ensure you apply to the correct hunt location. Incorrect or incomplete information may result in a voided application. Applicants ejected or prohibited from participating in ANY previous public managed hunt within Northern Virginia may be disqualified from participation and forfeit all associated fees.

2013 Mason Neck Management Hunt: Three (3) hunting days; Nov. 21, 22, & Dec. 13, 2013.

2013 Occoquan Bay Management Hunt: Two (2) hunting days; Dec. 9 & 11, 2013. **IF** staff determines the hunt has yet to reach desired management goals, an additional hunt day for **STANDBY** hunters may be added. Hunters unable to obtain a hunt permit for the first two hunt days may call to possibly hunt on Jan. 9, 2014. Staff will accept calls for the additional hunt day on January 3, 2014 at 8:00am at 703-490-4979 ext. 15.

2013 Youth Hunt: The Virginia Department of Game and Inland Fisheries will host a Novice Youth Deer Hunt on the Occoquan Bay NWR for hunters ages 12-18 on Dec. 7, 2013. This opportunity is for beginner hunters to participate in an afternoon hunt. Please note – The attached application form cannot be used for the Youth Hunt.

Applications: Applications must be postmarked no later than Sept. 20, 2013. Only one (1) hunter name can be associated with each application. Applications from several people may be mailed in the same envelope and covered by same check. Your application receipt date will be determined by postmark – Potomac River NWR Complex is not responsible for late or misrouted mail.

Application Fees: A \$10 fee is required for each hunting opportunity on your application - Mason Neck \$10, Occoquan Bay \$10, or Both Hunts \$20.
