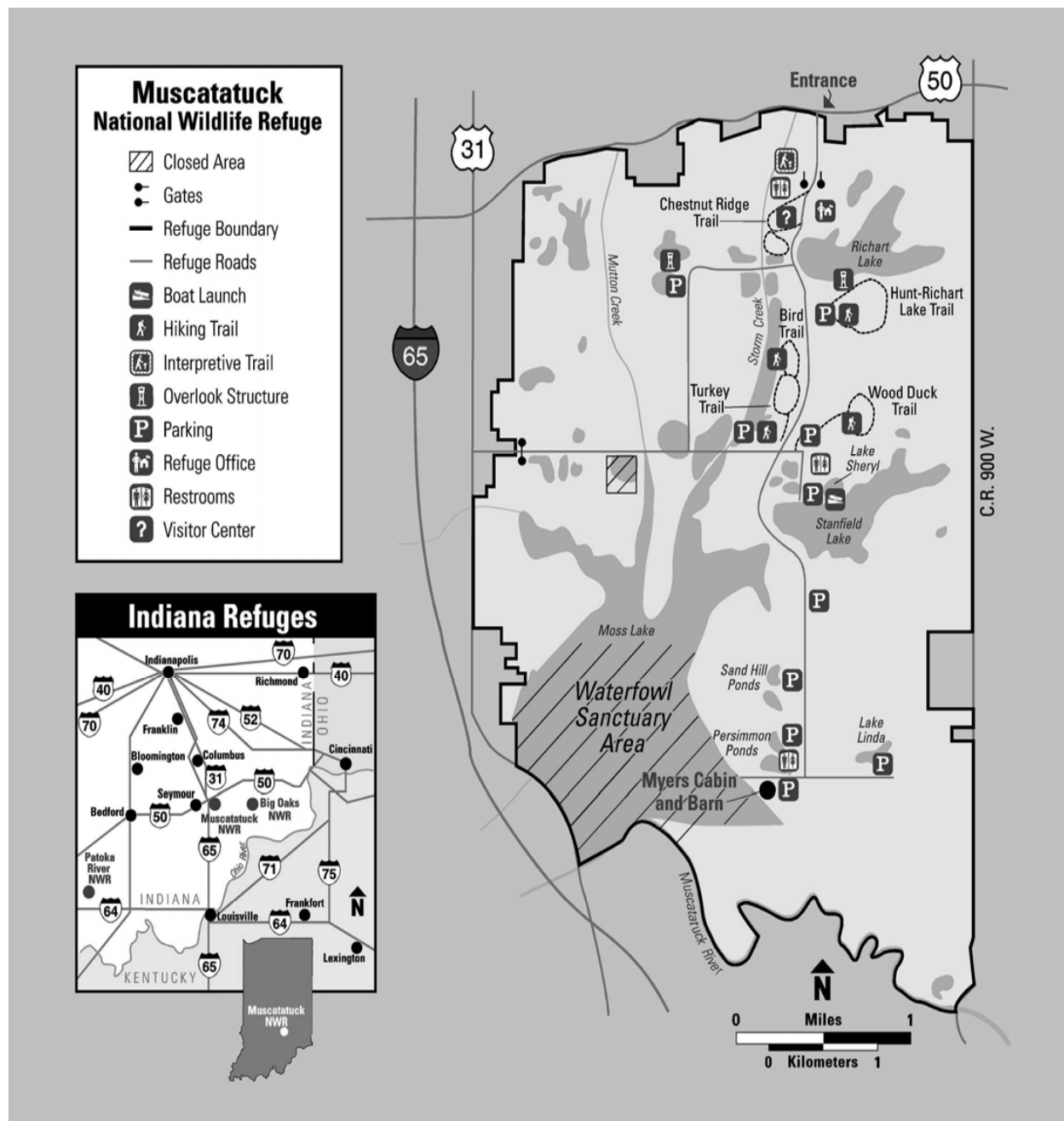

Rules and Regulations

- Refuge hours are one (1) hour before sunrise to one (1) hour after sunset seven days per week.
- Hunting and fishing are allowed in accordance with published refuge regulations in certain areas.
- Fishing areas are marked with “Public Fishing Area” signs.
- Edible mushrooms, nuts, fruits, and berries may be collected for personal use only. All other collecting of plants is prohibited.
- Shed deer antlers may be collected for personal use only. The collection of dead animal parts (and live animals) is not permitted.
- The sale of any items obtained from the refuge is prohibited.
- Bicycling is permitted only on gravel or paved roads. Riding on hiking trails is prohibited.
- Spotlighting wildlife is prohibited.
- Campfires and outdoor grills are not allowed.
- Swimming is not allowed.
- Off-road vehicle use is prohibited. Motor vehicle traffic is restricted to paved and gravel roads and parking areas.
- Entry into areas marked with “Area Closed” signs is not permitted.
- Visitors on foot are welcome in any open portion of the refuge

Rules and Regulations (continued)

- Horseback riding is not allowed.
- It is illegal to take, disturb, injure, or possess any wildlife or plants on the refuge except as authorized.
- It is illegal to release any wild or domestic animal on the refuge.
- The leaving of vehicles overnight on the refuge is not permitted.
- Filming motion pictures for commercial use requires a permit.
- Littering is prohibited. Please carry out what you bring in—litter kills animals!
- Searching for or removing any historic or Native American object or artifact from the refuge is not permitted.
- The use of metal detectors is not permitted.
