Pursuant to authority under Sections 104 of the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA or Superfund; Title 42, United States Code, section 9604) and Federal Executive Order 12580, on June 3, 2010, the U.S. Fish and Wildlife Service's Region 1 Director approved the preparation of an engineering evaluation and cost analysis to address the cleanup of lead contaminated structures and soil at the Midway Atoll National Wildlife Refuge on Sand Island, Midway Atoll. This response action is made pursuant to the National Oil and Hazardous Substances Pollution Contingency Plan (NCP) as found at Title 40, Code of Federal Regulations Part 300.


