Fishing Regulations

General Refuge Information

Welcome to Arrowwood National Wildlife Refuge, one of over 565 refuges and 38 wetland management districts in the National Wildlife Refuge System - a network of lands set aside specifically for wildlife. Managed by the U.S. Fish and Wildlife Service, the Refuge System is a living heritage, conserving wildlife and habitat for people today and for generations to come.

Refuge headquarters is open from 7:30 am to 4:00 pm, Monday through Friday, except for Federal holidays. The Refuge is open from 1½ hours before sunrise until 1½ hours after sunset.

The Refuge headquarters can be reached via Highway 281 by driving east on 11th Street SE for 5½ miles and 1 mile north on the refuge road. To reach the Refuge headquarters from Highway 9, travel west on 11th Street SE for 5½ miles and 1 mile north on the refuge road.

General Regulations

Vehicles are restricted to established trails open to public use.

Vehicles and trailers must not block access points.

Snowmobiles and all other off-road vehicles are prohibited.

Water activities not related to fishing (swimming, jet skiing, sailing, skiing, tubing, etc.) are prohibited.

Open fires, camping, and littering are prohibited.

Fireworks are prohibited.

Pets must be under the owner's control at all times.

General Fishing Information

Fishing is allowed on the Refuge in accordance with State and Refuge regulations. Regulations are set by the North Dakota Game and Fish Department and must be observed in all Refuge fishing areas. In addition, become familiar with all special Refuge regulations and access restrictions before entering the Refuge.

All fish allowed to be taken under State fishing regulations are legal on the Refuge. Species that may be present include northern pike, walleye, yellow perch, crappie, white sucker, big-mouth buffalo, bullhead, and common carp. Several non-game minnow species also inhabit Refuge waters.

Refuge fisheries are temporary and sporadic in nature. Fish occur in Refuge impoundments largely as a result of flooding events that allow fish to enter the Refuge from the Jamestown Reservoir. The impoundments are shallow and very productive, which allows fish to grow rapidly. Unfortunately, these impoundments are also subject to winterkill when fish suffocate from the lack of dissolved oxygen. When winterkill occurs, fish may naturally re-stock very quickly, or it may take years before Refuge waters again provide fishing opportunities.

Anglers requiring special accommodations should contact the Refuge Manager.

Boat Fishing Regulations

Motorized boats for fishing are allowed only on Arrowwood and Jim Lakes from May 1 through September 30 of each fishing year.

Boat motors are restricted to a maximum of 25 horsepower.

Only non-motorized boats may be used on Mud Lake.

The Refuge is closed to all boating from April 1 through April 30 and October 1 through March 31.

Primitive boat launch facilities are located in the Warbler Woodland Watchable Wildlife Area on Arrowwood Lake and at the southwest corner of Jim Lake.

Boat Access Regulations and Areas

The Arrowwood Lake boat fishing area extends from the inlet channel on the north side to the Arrowwood Lake Dam. A primitive boat launch, restrooms, and tables are located in the Warbler Woodland Watchable Wildlife Area.

Jim Lake boat fishing area extends from the Humpback Road on the north side to the Jim Lake Dam on the south side. A primitive boat launch is located at the southwest corner of the lake.

Bank Fishing Regulations

Bank fishing is allowed along the major road right-of-ways, interior portions of the Refuge, and the by-pass channel in accordance with State regulations.

Archery and Spearfishing Regulations

Archery fishing and spearfishing for non-game fish is allowed in accordance with State regulations.

It is illegal to return fish to the water after they are shot with an arrow or speared. All fish must be removed from the Refuge.

Ice Fishing and Darkhouse Spearfishing Regulations

Arrowwood and Jim Lakes, and the southern portion of Mud Lake, are open to ice fishing in accordance with State regulations.

Fish houses and vehicles, with the exception of snowmobiles and all other off-road vehicles, are allowed on the ice as conditions allow. Fish houses must be removed no later than March 15. After March 15, portable fish houses are allowed but must be removed daily.




Hunting Regulations

General Refuge Information

Welcome to Arrowwood National Wildlife Refuge, one of over 565 refuges and 38 wetland management districts in the National Wildlife Refuge System - a network of lands set aside specifically for wildlife. Managed by the U.S. Fish and Wildlife Service, the Refuge System is a living heritage, conserving wildlife and habitat for people today and for generations to come.

Refuge headquarters is open from 7:30 am to 4:00 pm, Monday through Friday, except for Federal holidays. The Refuge is open from 1½ hours before sunrise until 1½ hours after sunset.

The Refuge headquarters can be reached via Highway 281 by driving east on 11th Street SE for 5½ miles and 1 mile north on the refuge road. To reach the Refuge headquarters from Highway 9, travel west on 11th Street SE for 5½ miles and 1 mile north on the refuge road.

General Regulations

The area surrounding the Refuge headquarters is closed to all hunting and entry as shown on the map.

Off-road vehicle travel is strictly prohibited.

Snowmobiles and all other off-road vehicles are prohibited.

Parked vehicles must not block Refuge gates.

Open fires, camping, and littering are prohibited.

Persons possessing, transporting, or carrying firearms on National Wildlife Refuge System lands must comply with all provisions of State and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32).

General Hunting Information

Hunting is allowed in accordance with State and Federal regulations. It is the responsibility of the hunter to be aware of all special Refuge regulations and the boundaries of the hunting units before going afield.

Hunting is allowed for deer, pheasant, sharp-tailed grouse, partridge, fox, and cottontail rabbits as described below. Hunting of all other wildlife species is prohibited on the Refuge.

Legal hunting weapons are State-allowed firearm and archery equipment.

Hunters requiring special accommodations should contact the Refuge Manager.

Deer Hunting

The Refuge is open to North Dakota deer bow, youth, gun, and muzzleloader seasons.

A State-issued license is required to hunt deer on the Refuge. Hunters are restricted to the unit, species, sex, and weapon indicated on the license.

On the opening day of the respective youth, bow, gun, or muzzleloader season, hunters must wait to enter the Refuge until 12:00 pm (noon). Thereafter, hunters may enter the Refuge 1½ hours before sunrise. Gun hunters may not re-enter the Refuge after harvesting a deer unless un-armed and wearing blaze orange.

Bow hunters must wear blaze orange during the regular deer gun season.

Permanent tree stands are not allowed on the Refuge. Temporary stands, blinds, and game cameras are allowed, but must be removed daily. Stands, steps, or cameras may be clamped, roped, or chained to trees, but may not be nailed or screwed directly to trees.

The Refuge is open to deer hunting by foot travel. Vehicle access is NOT allowed for transporting hunters into or out of the Refuge.

Vehicles may use designated trails on the east side of the Refuge, as shown on the map, to retrieve harvested deer only during the following hours: 9:30 am to 10:00 am; 1:30 pm to 2:00 pm; and for 1 hour following legal shooting time. Retrieval times are posted on trail gates where vehicle access is allowed for retrieval. Hunting is NOT allowed while using a vehicle to retrieve a deer.

The auto tour route is closed to general public use during the youth, gun, and muzzleloader deer hunting seasons. Vehicles may be used on the auto tour route to retrieve harvested deer during bow season when it is open for general public use.

Bicycles, boats, and horses are prohibited from accessing the Refuge for deer hunting.

Baiting is strictly prohibited.

Upland Game Bird Hunting

Late season upland game bird hunting opens for pheasant, sharp-tailed grouse, and partridge on the first Monday after the deer gun season closes and remains open to the end of the State season.

Approved non-toxic shot is required for all shotgun hunting. Toxic shot may not be in the hunter's possession.

The use of dogs is encouraged, but they must be under control at all times.


Fox Hunting

Fox hunting opens the first Monday following deer gun season and closes March 31.

Cottontail Rabbit Hunting

Cottontail rabbit hunting opens the first Monday following deer gun season and closes March 31.

Refuge Signs and Their Meaning




Refuge Boundary
