**Job Location:** Crab Orchard National Wildlife Refuge, Marion, IL

**Application Deadline:** Original applications must be received at the Refuge Office by 4 p.m. April 15, 2014 by mail or in person. The Crab Orchard National Wildlife Refuge office is located at 8588 route 148 in Marion, IL, 62959.

**Youth Conservation Corps:** The Youth Conservation Corps (YCC) is a summer employment program for young men and women ages 15 through 18, who work, learn, and earn together by doing outdoor projects on public land. The goals are to accomplish needed conservation work on public lands, to provide gainful employment for America's youth, and provide an opportunity for participants to develop an understanding and appreciation for the nation's natural environment and heritage.

**Work Schedule and Salary:** YCC Crew Members work Monday through Friday, 40 hours per week, from 7:00 a.m. to 3:30 p.m. for an 8 week period from **June 9 to August 1, 2014.** Enrollees are expected to be available for the entire eight week program. Salary is \$8.25/hour. Crew members must have a checking or savings account in order to receive their Federal salary payment. Payments are made by *direct deposit* to a financial institution of their choosing.

**Eligibility and Selection:** No previous experience is required; selection is by random drawing. Four students will be hired to work with a YCC Crew Leader. To be eligible for the YCC program at Crab Orchard Refuge, applicants must:

- Be 15 to 18 years old, enrolled in school and a permanent resident of the United States.
- Furnish transportation to and from the Refuge maintenance shop located Route 148 in Marion, IL
- Possess a Social Security Card and Birth Certificate
- Have the consent and permission of a parent or legal guardian to apply.
- Attend the YCC Orientation Meeting scheduled for 5:30p.m. **May 6, 2014** to complete required federal employment forms (a parent or legal guardian must also be present).

**Typical Duties:** Youth Conservation Corps members will assist refuge personnel with a diverse range of projects, including:

- Grounds and Building Maintenance
- Wildlife Management Projects (beaver dam removal, invasive plant control, etc.)
- Maintenance of Trails and Visitor Access Areas
- Environmental Education and Recreation Programs

**Physical Demands and Hazards:** YCC positions will require hard work in an outdoor setting. Physical demands and environmental hazards may include:

- Use of hand tools such as hammers, shovels, rakes, wheelbarrows.
- Use of power equipment such as weed eaters, lawn mowers, drills.
- Repetitive lifting of up to 40 pounds of weight.
- Extensive hiking on sometimes rough terrain.
- Physically demanding work involving bending, pulling, digging, and lifting.
- Exposure to summer heat, rain and demanding field conditions.
