KIDS FISH FOR FUN RULES **PLEASE READ ALL RULES CAREFULLY!**

- FISHING EVENT IS FOR THE KIDS!! PARENTS SHOULD ASSIST ONLY WHEN NECESSARY. ADULTS ARE NOT ALLOWED TO FISH.**
- Anglers must be 3 years to 12 years old** and accompanied by parent or guardian.
- Parents and guardians should watch children closely. Ponds are deep. Fishing is **not** allowed from the concrete structures, due to danger of falling. Wading and swimming are prohibited in all areas on federal property.
- There is a 5 fish limit on a single stringer. Upon catching the 5 fish limit, please stop fishing. Each child is entitled to one stringer with 5 fish. Each child may possess one fishing rod; no adult to have fishing rods. Anglers will provide their own fishing tackle and bait (fishing for catfish). No minnows or cut bait. Please **leave buckets and coolers in your vehicle.**
- A time limit will be enforced so that all children will be given an opportunity to fish. No more than 100 children will be allowed to fish around the pond for safety reasons. Each group will be given the same amount of total time to fish. If child does NOT catch any fish, please advise pond patrol.

SUGGESTIONS:

Anglers should pay close attention to the person fishing next to you; we do not want anyone to get HURT OR hooked. Anglers are expected to be courteous to one another. Horse play and rude behavior are not allowed. A responsible parent or guardian should remain with child throughout the event in case of an emergency. Uniformed personnel and volunteers are present to assist you if needed. Please do not hesitate to ask for help. Please do not litter. Place trash in receptacles.
