CERTIFICATE OF APPORTIONMENT OF \$404,449,843 OF THE APPROPRIATION FOR DINGELL-JOHNSON SPORT FISH RESTORATION TO THE STATES, THE COMMONWEALTH OF PUERTO RICO, GUAM, THE U.S. VIRGIN ISLANDS, AMERICAN SAMOA, THE COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS, AND THE DISTRICT OF COLUMBIA FOR FISCAL YEAR 2009

Pursuant to the Dingell-Johnson Sport Fish Restoration Act, as amended (16 U.S.C. 777 et seq.), we have, at this time, apportioned \$404,449,843 to the States, the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, the Commonwealth of the Northern Mariana Islands, and the District of Columbia. The funds so apportioned are based on the amount credited during Fiscal Year 2008 to the Sport Fish Restoration Account. A preliminary apportionment of \$273,476,986 was made on November 5, 2008, and is included as part of this final apportionment. The funds are available for the fiscal year beginning October 1, 2008, and are available for the period of time specified in the Act.

The amounts apportioned to the States are as provided by Section 4 of the Act, and adjusted so no State shall receive more than 5 percent or less than 1 percent of the total amount apportioned.

The amounts apportioned to the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, the Commonwealth of the Northern Mariana Islands, and the District of Columbia are as provided by Section 12 of the Act.



Therefore, in accordance with the above, the preliminary apportionment of Dingell-Johnson Sport Fish Restoration funds for Fiscal Year 2009 is as shown on the enclosed tabulation.

CERTIFICATE OF APPORTIONMENT OF \$336,474,545 OF THE APPROPRIATION FOR PITTMAN-ROBERTSON WILDLIFE RESTORATION (CFDA NO. 15.611) TO THE STATES, THE COMMONWEALTH OF PUERTO RICO, GUAM, THE U.S. VIRGIN ISLANDS, AMERICAN SAMOA, AND THE COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS FOR FISCAL YEAR 2009.

Pursuant to the Pittman-Robertson Wildlife Restoration Act, as amended (16 U.S.C. 669 et seq.), I have, at this time, apportioned \$336,474,545 to the States, the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands. The funds so apportioned are based on the amount credited during Fiscal Year 2008 to the Federal Aid to Wildlife Restoration Fund. A preliminary apportionment of \$240,541,414 was made on November 5, 2008, and is included as part of this final apportionment. The funds are available for the fiscal year beginning October 1, 2008, and are available for the period of time specified in the Act.

Of the total amount apportioned, I have made \$271,407,252 available to the States as provided by Section 4(b) of the Act. The amounts apportioned to the States are adjusted so that no State shall receive more than 5 percent or less than one-half of 1 percent of the amount apportioned under Section 4(b). In addition, I have made \$328,523 available in accordance with Section 10(c)(2) of the Act, apportioning this amount in accordance with Section 4(b). Amounts apportioned to the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands are as provided by Section 8A of the Act.

Of the total amount apportioned, I have made \$56,738,770 available as provided by Section 4(c) of the Act. The amounts apportioned to the States are adjusted so that no State shall receive more than 3 percent or less than 1 percent of the total apportioned under Section 4(c).



Of the total amount apportioned, I have made \$8,000,000 available as provided by Section 10(a) of the Act. The amounts apportioned to the States are adjusted so that no State shall receive more than 3 percent or less than 1 percent of the total apportioned under Section 10(a). Amounts apportioned to the States, the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands are as provided by Section 4(c) of the Act.

Therefore, in accordance with the above, the final apportionment of Pittman-Robertson Wildlife Restoration funds for Fiscal Year 2009 is as shown on the enclosed table.
